APPLICATION OF FEES SPECIFIED IN SECTION II

The fees specified in Section II shall be charged in the currency of transaction or in the Ukrainian currency equivalent at the NBU exchange rate effective on the date of transaction.

The fee specified in p.2.1 shall accrue from the issuance date of a guarantee/ counter-guarantee/ standby L/C and acceptance date of a stand-by L/C, on the amount of commitment for the actual number of days of the effective period of guarantee/ counter-guarantee/ standby L/C based on a banking business year of 360 days. The fee may be increased by fees actually charged by correspondent banks.
